132ND QUARTERLY REPORT

PURSUANT to section 53 (9) of the Advocates Act and Rule 12 (1) of the Advocates (Complaints Commission) Rules, 1991, it is notified for general information that from the 1st October, 2023 to 31st December, 2023, the Commission received a total of three hundred and three (303) new complaints and submitted them for enquiry under the Preliminary Enquiry Initiative. The current status of the above new complaints is as shown below:
